Fleamarket Application Form

Welcome to the 2007 Dayton HAMVENTION®.

Please note the February 3rd date for same space requests has been moved to February 15th.

There has been a modification to the physical layout of the fleamarket this year.

Many vendors have asked to have more end cap or corner spaces available. These changes will begin providing this type of fleamarket space in greater numbers.

This will cause some inconvenience. Persons whose 2006 spaces become part of an aisle will be moved. If you previously had the space that became the newly created corner, you will be charged the higher price or may move to a different location. Please see the Aisle Space Changes sheet for an indication of how we intend to handle these changes. We **WILL** work with you as best we can to arrive at a good solution, but the Fleamarket Committee decisions must be final.

Corner spaces on the west side of the fleamarket will also be priced at the new price.

Additionally, while the minimum space cost will not be changing, the total cost of having additional spaces will be lower this year.

This order form is good for ordering up to eight fleamarket spaces. If you wish more spaces, please contact the Fleamarket Committee. Please use this form for contact, but of course, do not fill in the prices until you have been quoted a rate. Thank you.

The approximate size of each fleamarket space is about 9 ft by 17 ft or 153 square feet. You must plan to park any vehicle that extends into the pedestrian aisle in the courtesy lot on either the east or the west end of the fleamarket. See the 2007 Dayton HAMVENTION® Fleamarket Rule sheet. If you have back-to-back spaces, you can easily place a large vehicle in them.

If you are going to have a tent, fly, or a pop-up of any kind covering more than 200 square feet, you must have **both** county and city permits and an inspection. The Dayton HAMVENTION® Committee will assist you in obtaining this paperwork. See page two.

If you are requesting a special RADIO CLUB space please fill out the contact information and send it in without payment. We will contact you directly about space and admission tickets. Please remember that we have only a limited number of spaces available.

Please be sure to read the Ohio Tax Letter, the HAMVENTION® Fleamarket Rules and the 2007 Rate Sheet to be sure to get the proper cost information.

2007 DAYTON HAMVENTION® FLEA MARKET AGREEMENT

THIS AGREEMENT is made by and between the Dayton Amateur Radio Association, Inc, DBA DAYTON

HAMVENTION® and VENDOR _____,
VENDORS' Legal Name (Please Print)

VENDOR and Dayton HAMVENTION® agree to the following:

1. BOOTH SPACE: That in consideration of \$ _____, Dayton HAMVENTION® will provide and assign to the VENDOR

a vending area of _____ Flea Market spaces.

2. SPECIAL SERVICES:

That any other services or fixtures may be contracted for, by, and solely between the VENDOR and Dayton Hara Arena Complex or any other contractor and at all times shall remain subject to approval by Dayton HAMVENTION®. All outside contractors must have Dayton HAMVENTION® approval prior to providing any services to VENDOR.

3. TERM OF AGREEMENT:

That this Agreement will govern the conduct of the parties from Thursday, May 17, 2007 at 8:00 a.m. until Sunday, May 20, 2007 at 10:00 p.m. EDT while on the grounds of HARA Arena, except in the event of any cancellation or termination of Dayton HAMVENTION®, at which time this Agreement will end upon the VENDOR's exit from Dayton Hara Arena Complex. Any exception must have written approval of Dayton HAMVENTION®. Both parties waive any claims for damages or compensation as a result of this cancellation or termination. Ohio Law shall govern this Agreement.

4. EXHIBITS:

A. That the Dayton HAMVENTION® site at the Dayton Hara Arena Complex shall be available for the unassisted installation of displays on May 17, 2007 from 8:00 a.m. until midnight and on May 18 and 19, 2007 from 6:00 am until 7:30 am. Any other times require approval and assistance of the Fleamarket committee

B. That the Dayton HAMVENTION® site at Dayton Hara Arena Complex shall be available to dismantle displays on May 20, 2007 from the time the displays close until 6:00 p.m. Display materials and Exhibits must be removed from the Dayton HAMVENTION® site by 8:00 pm. May 20, 2007 *unless written arrangements are made with Dayton HAMVENTION®.*

5. DAYTON HAMVENTION ACTIVITIES:

That the VENDOR shall be solely and completely responsible for the installation and dismantling of his exhibit, and for the operation of his assigned display area, including the sale of goods, compliance with all applicable safety, licensing, tax, or other regulations and shall hold the Dayton Amateur Radio Association, Inc., and Dayton HAMVENTION®, its members, agents, and servants harmless from all liability which may result either directly or indirectly from VENDOR activities. All VENDOR activities shall comply with the Rules and Regulations imposed upon Dayton HAMVENTION® by reason of its master agreement with the Dayton Hara Arena Complex. At our sole discretion, Dayton HAMVENTION® reserves the right to remove from the Dayton Hara Arena Complex any VENDOR found not to be consistent with the amateur radio/electronics hobbyist nature of the show or of any exhibitor who fails to comply with the conditions of this Agreement.

6. SECURITY SERVICE:

That Dayton HAMVENTION® will provide limited security service in or about the Fleamarket area on May 18, 2005 commencing at 8:00 a.m., and continuing until the exhibit area is cleared of spectators on May 20, 2007. Dayton HAMVENTION®, DAYTON HARA ARENA, AND/OR THEIR CONTRACTORS DO NOT GUARANTEE THE SECURITY OF THE EXHIBIT AREA OR PERSONAL PROPERTY AND SPECIFICALLY DISCLAIMS RESPONSIBILITY FOR LOSSES OF MERCHANDISE.

7. HOLD HARMLESS:

That VENDOR shall Hold Harmless/indemnify Dayton HAMVENTION®, its agents, representatives, officers, directors and Dayton Hara Arena Complex from all liability, loss, claims, suits and/or judgments arising from VENDOR's negligent or intentional wrongful acts or omissions. Dayton HAMVENTION® disclaims responsibility for injury to any persons resulting from VENDOR negligent or intentional wrongful acts or omissions.

8. LIMITATION OF LIABILITIES:

That under no circumstances shall Dayton HAMVENTION® or any affiliated entity have any liability whatsoever for incidental or consequential loss or damages such as, without limitation, lost profit or revenue, loss of use, increased costs or expense, or claims resulting from agreements of VENDOR and third parties. VENDOR at all times remains solely liable for penalties, liquidated damages, indemnification of Dayton HAMVENTION® and others.

9. ACTS OF GOD:

That the Dayton HAMVENTION® shall not be liable for delay or nonperformance attributable to war, fire, flood, acts of God, acts of third parties, terrorism, acts of governmental authorities, accidents, work stoppage, riot and disobedience, equipment breakdown or other measures beyond our reasonable control. No requests for refunds will be honored after April 15, 2007.

10. EXHIBITOR RESPONSIBILITY:

That the Exhibitor shall assure adequate manning of his space at each day's opening of the Fleamarket area to Dayton HAMVENTION® attendees. Lost registration tickets or parking passes may be replaced at the discretion of the Fleamarket Committee, for a fee.

Assignment of this AGREEMENT and subletting or sharing of a display area without the written permission of Dayton HAMVENTION® is prohibited.
