2020 Flea Market Rules Addendum

(Rev.1)

As the 2020 Dayton Hamvention® is once again being held at the Greene County Fairgrounds, there are a variety of rules that **ALL** vendors must remain aware of. This is especially true regarding the Flea Market portion of the event. The Flea Market is comprised of locations both inside and outside of the race track area. Since the Flea Market “Infield” area is shared with the horses and trainers, located at the Greene County Fairgrounds, as a vendor in the Flea Market, it is important that you read and understand the following:

1. During the Hamvention®, the Flea Market will be opened to the general public, at 9:00 am each day and will close at 5:00 pm on Friday and Saturday.
2. Vendors will have access to this area on Thursday, from 7:00 am through 7:00 pm, to set up their spaces.
3. On Friday, Saturday and Sunday, vendor access to the Flea Market will begin at 6:00 am, **NOT BEFORE.**
4. Vendors must be clear of the Flea Market area, no later than 7:00 pm on **ALL** days. **NO EXCEPTIONS!**
5. **NO OVERNIGHT STAYS** will be permitted in the Flea Market area. The area will be patrolled and this rule will be enforced by the Hamvention® Security Staff.
6. Vendors may begin staging, at the Flea Market entrance, prior to its opening, at 6:00 am on Thursday and Sunday and at 5:00 am on Friday and Saturday.
7. Any vendors that have not entered the Flea Market area, prior to 8:45 am, will be escorted to their space(s), by a Flea Market golf cart escort.
8. The aisles of the infield area of the Flea Market must be cleared of all vehicles, prior to 8:45 am, each morning (Friday, Saturday and Sunday), as the Fire Marshall will not permit opening to the public, with any aisles being obstructed. No vehicles are permitted to occupy any aisle areas, during the hours of operation. Vehicles in violation will be subject to being towed, at the owner’s expense.
9. Any vendors needing to leave the Flea Market area, prior to the 5:00 pm closing time, must be escorted by a Flea Market golf cart.
10. Vendors not needing to drive into the infield Flea Market area may continue to have access to the Courtesy Parking area, throughout the day, between the hours of 6:00 am and 7:00 pm.
11. Moving vehicles (cars, trucks, campers, motor homes, etc.) will not be permitted, in the Flea Market selling area, during the open hours of the Flea Market, unless being escorted by a Flea Market escort.
12. The Courtesy Parking area will be on the actual race track surrounding the infield, as well as in the Front Lot area. Access to the Courtesy Parking area will **ONLY** be between the hours of 6:00 am and 7:00 pm. Any vehicles still parked in the either of these areas, outside of these hours will be towed, at the owner’s expense. There will absolutely be **NO PARKING** on the track outside of these hours!

Please remember that the Dayton Hamvention®, its staff and visiting guests are all sharing the Greene County Fairgrounds for one week of the year and that the track and area surrounding it are home to many horses and their trainers. Please remain respectful of the venue and its occupants, as we are guests in their home and as always, please be patient with everyone; staff, vendors and visitors alike, while we work through any issues.
