Any deviation from the aforementioned rules will subject the approval to be reviewed and potentially suspended or revoked, at the discretion of the Flea Market Chairman. In the case of a dispute of the suspension or revocation, the Hamvention® General Chairman shall retain the right of making the final determining decision.

Please read and understand the details being requested, before filling in, signing and submitting this form for approval. Any changes in the individual approved to receive the Ham Club Discount may require the submission of a new application. Approved requests will have the discount applied to the current year's event, however, discounts are not permanently applied, from one year to the next. Vendors must send an e-mail to the fleamarket@hamvention.org each year, for the discount to be applied. Vendors requesting a discount should not make payment for their reservation until the Flea Market committee has applied the discount. Once the discount has been applied, payment for the reservation can then be completed.

NOTE: Although club newsletters may be submitted to support the validation, they cannot be considered as the sole source of validation. Also note that, GMRS repeaters, their clubs or organizations may exist without any amateur radio related functions or requirements and therefore **cannot** be considered eligible for the Ham Club discount. As these organizations/groups can exist and licenses can be obtained without any testing or other technical requirements as set forth by the FCC for obtaining an amateur radio license, a GMRS license in itself does not meet the criteria of a FCC or ARRL recognized amateur radio club.
